1. INTRODUCTION

University Law College is a constituent college of the Utkal University, which started functioning from University campus from the Academic Session 1975-76. The college achieved a glorious record in a very short span of time and became a most sought and preferable institution by the students desirous of pursuing legal education. In the course of time, this glorious institution has earned a name and fame for itself and has been the cradle for Judicial Magistrates, Law Makers, Lawyers of eminence, Administrative Officers, Executives, Corporate Personnel and Social Activists. The college shifted to its own premises located at Vani Vihar Square on the side of N.H.-5 within the Utkal University Campus in the year 1996. This important institution which is situated at the heart of the capital city, is well connected with rail/road/air services with major cities of the State and the Country.

2. OUR VISION

The vision of the College is not only to produce students with legal draftsmanship and legal expertise and fit for Bench and Bar but also to inculcate amongst them a spirit for helping those who are in need of justice. Here each student is treated as a budding legal scientist and every care is being taken to make the student achieve the academic and professional excellence. Some broad objectives of the college are:

a) To inculcate amongst the students the cultural, ethical and legal values in order to

promote the rule of law in the society.

- b) To educate the students with basic principles of laws with critical evaluation thereof.
- c) To make the students aware with the new areas of law by organizing Seminars, Moot Courts, Symposia and other co-curricular activities.
- d) To spread the legal knowledge among the citizens and to create awareness among weak and vulnerable sections of the society.

3. PROGRAMME OFFERED

Utkal University is imparting the Five year Integrated B.A.LL.B.(Hons.), CBCS Course at its constituent Colleges i.e. University Law College, VaniVihar, Bhubaneswar. The course has been designed in the same line taking into account the standards prescribed by the UGC and Bar Council of India, New Delhi. This course is at par with the syllabus prescribed by leading Universities/Law Schools in India offering Five Year Integrated B.A., LL.B. (Hons.) Programme in law.

4. STUDENT STRENGTH

The student strength of the course is 60 per year.

5. ELIGIBILITY REQUIREMENTS

A candidate shall be eligible for admission into 5-yr B.A.LL.B (Hons.), CBCS Course, if he/she has passed +2 Examination (at least 10+2 pattern) securing a minimum of 45% marks in aggregate for General category and 40% marks for SC/ST category.

6. APPLICATION PROCEDURE

6.1- The candidates are required to download the application form from our website www.universitylawcollegbbsr.org.in and the filled in application form with requisite documents along with application fees of Rs. 600/- (Rupees six hundred only) in the shape of **DD drawn in favour of the Principal, University Law College, Bhubaneswar payable at Bhubaneswar can be sent to Principal, University Law College, Vani Vihar, Bhubaneswar 751007 by speed post so as to reach us on or before the last date.** The application form can also be submitted in the office counter during the office hours.

6.2- The application form duly filled in by the candidate shall reach the office of the Principal on or before the last date mentioned in the advertisement/notification. The forms can be submitted either by person or by post. The institution shall not be held liable for any postal delay. Applications received after last date or incomplete in any respect would be summarily rejected.

N.B.:-The following documents are to be attached along with the Application Form. No enclosures will be entertained after the submission of the application form.

- i) Self Attested copy of HSC/SSC or equivalent Certificate and Marksheet.
- ii) Self Attested copy of CHSE/SSE Certificate & Marksheet.
- iii) Self Attested copy of Conduct Certificate from the Institution last attended.
- iv) Self Attested copy of Caste Certificate in case of SC/ST category.

- v) Self Attested copy of PH Certificate in case of Physically Handicapped category.
- vi) One Passport size (2.5cm x 3.5 cm) photographs signed by candidate.
- vii) Original Bank Draft/ Demand Draft towards fees for Application Form.

Note : Certificates issued by the following Authorities would only be entertained.

- i) Caste certificate : Collector, Addl. District Magistrate, Sub-Collector, Gazetted Local Revenue officer, D.W.O not below the rank of Deputy Collector, Tahasildar of the area.
- ii) Handicap certificate : C.D.M.O. of the District only with Identity card issued by the appropriate authority.

7. ADMISSION PROCEDURE

7.1- Selection of the students shall be made strictly on the basis of carrier-cum-entrance test with the following Break-up of marks (30 percent of the carrier and 70 percent of the entrance test)

7.2- The written test will be of objective MCQ type questions with four alternatives. The candidates have to give answer in OMR sheet and valuation will be done by OMR reader.

7.3- All admissions are provisional and the same cannot be claimed as a matter of right.

8. RESERVATION

Reservation of seats will be as follows:

1. 16.25% of the seats for the SC and 22.50% for ST (interchangeable). In case of non-availability of candidates in one of these categories, seats will be filled up from the candidates of the other category.
2. 5% of the total number of seats will be reserved for physically handicapped students at the time of admission. In case of non-availability, the seats will be filled-up from the merit list.
3. 1% of the seats for son / daughter of Ex - Servicemen.

N.B.:- However the reservation is subject to rules framed by the Govt. of Odisha from time to time.

9. WEIGHTAGE

Weightage and special consideration will be given in the following cases:

Sports - The following categories of sports persons will be given admission/weightage under the sports category subject to selection of a maximum of 2% of total number of seats.

- i) Representing the country at International level - Direct Admission.

- ii) Representing the State at National level - 10% additional mark over the aggregate.
- iii) Representing the University at Inter-University level - 5% additional mark over the aggregate.
- iv) The above-mentioned sports must be recognized or organized by the **Director of Sports Govt. of Odisha or University Sports Council**. In order to get the weightage in sports the concerned applicant must have participated in the respective competitions **within three years** before the date of application for admission.

N.B. - The above rules regarding reservations and weightage are however subject to rules framed by the Government of Odisha in this regard from time to time. The merit list in ultimate drawn by the Institution shall be final for all purposes.

10. DESPATCH OF INDEX AND INTIMATION CARDS AND ADMIT CARD

10.1 The applicant has to collect index card from the college office after last date of submission of application form.

10.2 Admit card can be downloaded from the college website: www.universitylawcollegebbsr.org.in by indicating their index number and their name or it can also be collected from the college office within two days before the date of entrance test.

10.3 Intimation letters for the selected applicants for admission will be sent in due course by registered E-mail only and due notification to that effect will also be made available on the Notice Board and college website for the information of the candidates. The candidates are advised to visit the college website to ascertain their respective ranks

in the merit list and date of admission.

11. MISCELLANEOUS PROVISIONS

11.1 Suppression of the facts or giving incorrect information by the applicant if detected shall render his/her selection invalid. All selected candidates shall be provisionally admitted subject to verification and cross checking of marks submitted by them by the college authorities.

11.2 The decision of the Principal regarding matters pertaining to admission shall be binding and final

11.3 Students continuing and prosecuting any other courses shall not be permitted to take admission. The studentship certificates shall not be considered for admission.

12. COURSE FEE

Each candidate is required to pay a Sum of Rs. 45000/- (Rupees Forty five thousand) only per annum towards course *fee* at the time of admission in shape of Bank Draft drawn in favour of the Principal of respective colleges where he is admitted. Admission fee can also be deposited through challan which is available in the College Office. However, the course *fee* is subject to change in accordance of the decision of the University which will be intimated to the candidates sufficiently ahead of their re-admission.

Beside the above course fee, a University Registration fee amounting to Rs. 150/- (Rupees One hundred fifty only) shall be collected from each student.

13. DURATION OF SEMESTER

Each Semester shall not be less than 15 weeks duration with not less than 30 class hours per week including tutorials, moot room exercise and seminars provided there shall be at least 24 lecture hours per week.

14. ATTENDANCE

14.1. A candidate in order to qualify him /her self to appear the Semester Examination shall have to secure at least 75% of classroom attendance in each paper of that Semester.

14.2 A candidate who represents the Institution in any International/National/State level Academic/Sports Competition with prior permission of the Principal shall be awarded with 15% class room attendance during that Semester.

14.3 A candidate, who has secured 60% to 74% of classroom attendance due to illness, may submit a Medical Certificate from a Regd. Medical Practitioner for adjustment of deficit attendance.

14.4 The Principal shall enjoy the prerogative to award 10% of classroom attendance to a candidate.

15. SYSTEM OF EXAMINATION

Each course will have a total of 100 marks. The University's Examination Division will conduct a written exam at the end of each semester for all courses, which will be worth 70 marks. Additionally, each course in each semester will have internal evaluations worth 20 marks, which

will be based on a written project and presentation. Mid Semester Examination will also be considered and worth 10 marks. For Theory and Activity Based Courses, the examination system shall be different as per details given below:

15.1. **Theory Course**

The scheme of examination for theory course shall include:

A. Internal Assessment

- i. The Internal Assessments in theory courses will comprise of written project/presentation and written test, such assignment shall carry 30 Marks, of which 20 Marks will be for written project/presentation and 10 Marks for written test. There will be no internal assessment in paper -VI of both IXth and Xth Semester Examination.
- ii. The written project/presentation and written test of the Internal Assessment shall be conducted by the teacher concerned, on a date fixed by the Principal. Each Student has to prepare the project on the topic given by the concerned faculty. It will be evaluated for 20 Marks for written project report/presentation of the report. The concerned teacher shall submit the result of Internal Assessment to the Principal who shall forward the same to the Controller of Examinations, Utkal University.
- iii. Where a candidate fails to take examination in any one or more subject or having taken the examination has failed to secure the minimum pass marks in any one or more subjects or in the aggregate, his Internal Assessment marks shall be carried

forward to the subsequent examination. The absentee or failed candidate shall have to clear all examinations within next two consecutive years. Besides a candidate securing less than 35 mark in a paper including Internal Assessment or less than 50% of the marks in aggregate in the end semester examination may reappear the said examination within the next two consecutive chances.

B. End Semester Examination and evaluation for 70 Marks

At the end of each semester, there shall be a University Examination for 70 Marks. 1st, 3rd, 5th, 7th and 9th Semesters will be held in the Month of December and 2nd, 4th, 6th, 8th and 10th Semesters will be held before the Month of June. The Controller of Examinations, Utkal University shall notify the examination schedule on completion of courses.

16. The Credit System

The credits specified for 5 year Integrated B.A. LLB (Hons.) programme describe the weightages of various courses of the Programme. The number of credits along with grade points that the student has satisfactorily completed measures the performance of the student. Satisfactory progress of a student is subject to his/her maintaining a minimum Cumulative Grade Point Average (CGPA), as well as minimum grades in different courses of the programme. A certain number of credits must be earned by the student to qualify for the degree. Description of credit distribution for Core Courses, Activity Based Courses and Elective Courses has already been shown. . . .

16.1 Assignment of Credits:

Credits of a course shall be assigned in the following manner:

(a) For all theory (lecture) courses, one credit shall be assigned for one- hour lecture per week in a semester.

(b) Credits shall be in whole numbers.

(B) The performance of a candidate in a semester or upto a semester shall be measured by SGPA and CGPA, details of which are given below :

SGPA: Semester Grade Point Average.

CGPA: Cumulative Grade Point Average.

Calculation of Semester Grade Point Average (SGPA) and

Cumulative Grade Point Average (CGPA) :

Where

C_i = Number of credits assigned for the i^{th} course of a semester for which SGPA is to be calculated.

P_i - Grade point earned in the i^{th} course.

$i = 1 \rightarrow n$, represent the number of courses in which a student is registered in the concerned semester.

(ii)Where

C_j =Number of credits assigned for the j^{th} course, up to the semester for which CGPA is to be calculated.

P_j =Grade point earned in j^{th} course.

J = 1---- m, represent the number of courses in which a student was registered up to the semester for which CGPA is to be calculated.

17. Script and Duration of Examinations.

- (i) Except when otherwise directed by the Regulation or by the examiner in the examination paper, every candidate shall answer questions in English Language in the examination in all the courses.
- (ii) Each individual paper shall be of 3 (three) hours duration.

18. Evaluation Pattern:

Non-appearance in I examination (Incomplete)

Explanation:

Letter grades O, E, A, B & C in a course mean that candidate has passed that course.

If a candidate secures minimum of 35 marks in individual paper(s) (Theory+Internal) but obtains 50% or above marks in aggregate in the end semester examination, such candidate will be awarded Grade according to the percentage. The candidates must secure at least 25 marks out of 70 marks in theory paper.

The F grade denotes poor performance, i.e., failing in the course. A student has to appear at subsequent examination(s), (next two consecutive chances only) as provided in the regulation in all courses in which he /she obtains "F" grade, until a passing Grade is obtained.

The I Grade is awarded, when a student does not appear in the examination of course/ courses. This shall be treated as "F" Grade.

19. Grace Rule: Grace mark shall be awarded as per the following Guidelines :

19.1. 1% of the total marks in aggregate can be awarded to a candidate for enabling him/her to pass in a semester examination provided he/she secures minimum 35 marks in individual paper(s).

19.2. The candidate(s) securing I Grade will not be eligible for grace mark.

19.3 Grace Mark will not be awarded for making up shortfall in minimum pass mark in individual paper or to obtain division or in CGPA.

20. DEGREE REQUIREMENTS

A candidate will be eligible for award of B.A. LL.B (Hons.) degree if he/she satisfied the following:

- 20.1. Has Secured CGPA 6.0 or more.
- 20.2. Has cleared the credit requirements with pass grade or more in each subject.
- 20.3. Has at least a satisfactory conduct.
- 20.4. Has cleared all the theory, activity based and elective courses of all semesters.
- 20.5. The passed candidates may be awarded with the division according to the following

criteria:

Note: The SGPA and CGPA shall be computed upto 2 places of decimals (truncated at the second place).

The Conversion formula for converting CGPA to the corresponding Percentage of Marks will be as follows:

21. RANKING TO THE CANDIDATE

- 21.1. Ranking shall be given to only those candidates who pass all the courses of the programme in one attempt.
- 21.2. The marks obtained by him/her at the examination shall be considered as the basis for the University Ranking, Scholarships and other distinctions.
- 21.3. In order to get the benefit of this provision the student should claim that he/she is eligible for this benefit and get a decision in writing after proving his/her eligibility there for.

22. DRESS CODE

For Boys- White Shirt, Black Trouser, Black Tie, Black Coat, Black Shoes and White Socks.

For Girls- White Kurta, Black/ White Salwar, Black Dupatta, Black Coat, Black Shoes and White Socks

23. ACADEMIC CURRICULUM

Limited seats are available for the girl students only. Selection for the Hostel Shall be done on the basis of merit cum distance. After admission process is over, the students shall apply in the prescribed form for selection.

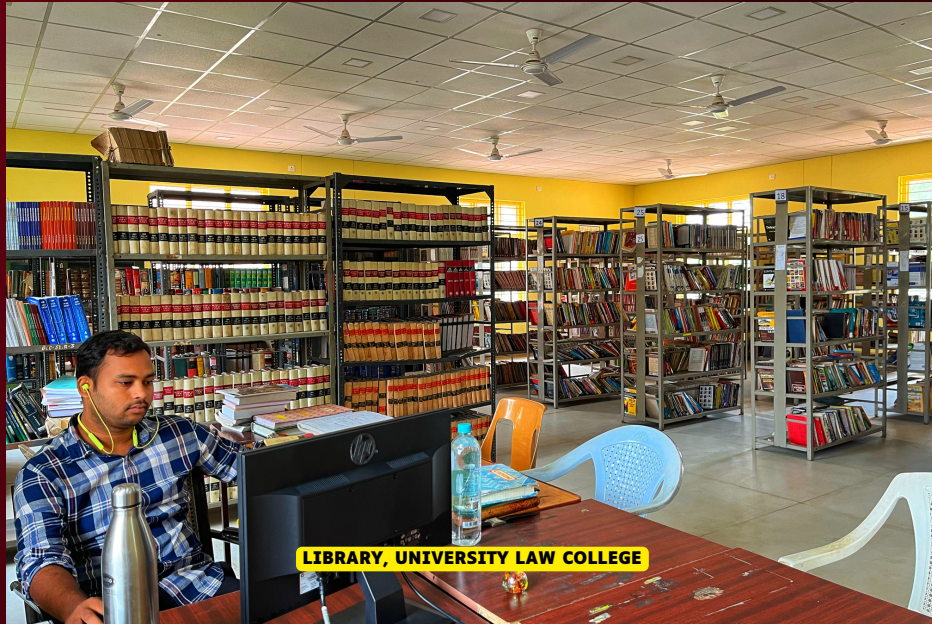

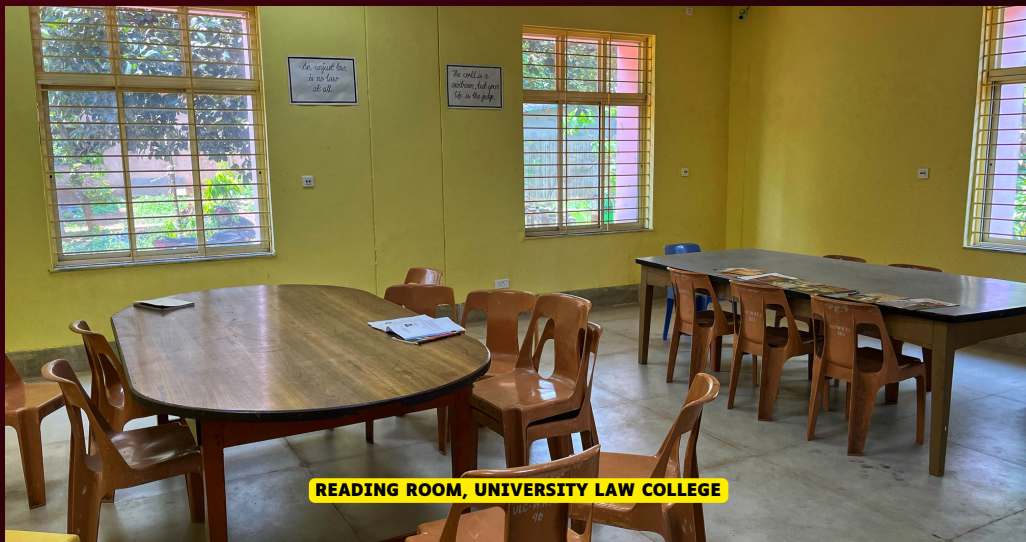




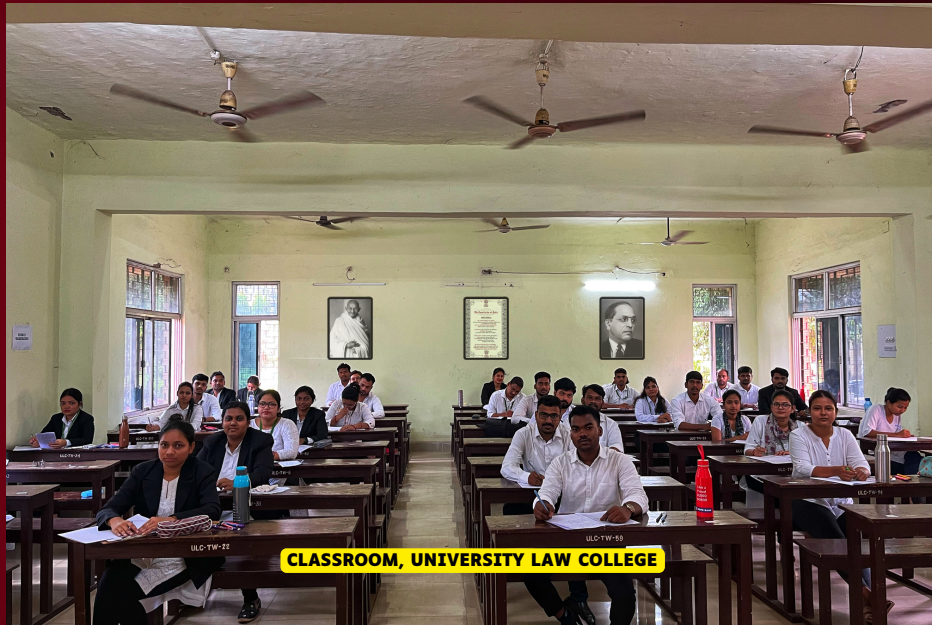
